compliance with these provisions, said proposal will be automatically lapsed without any right or pre-emption by the customer.

2. Upon receipt of the confirmation, the terms on the cancellation policies and payment options as well will be effective.
3. Any subsequent correspondence regarding the performance formalities thus defined will form an integral part of the official agreement.
4. If, for any reason, the conference does not take place, the commitments of participation shall be deemed canceled. No consequences will be charged to SiVà snc, who will only refund the amount paid in advance by the Company.

## Billing and Payments

## Cancellation/Penalty

1.	In case of partial or total cancellation, after the receipt from SiVà of the confirmation and up to May 25th 2015 you will be debited an amount to title of penalty equal to the 50% of the annulled share
2.	In case of cancellation from May 26th 2015 you will be debited an amount to title of penalty equal to the 100% of the annulled share
3.	If the payments are not effected in the terms above anticipated, the agreement stipulated with SiVà snc will be resolved by law automatically, to the senses and for the effects of the art. 1456 Civil Code, on sending a declaration by registered letter with mail confirmation. The unfulfillment from the client will be therefore understood as cancellation with application of the terms of penalty.
4.	The missed receipt of the balance before the congress, can be valid motive for SiVà snc to forbid the assemblage of the booth or to exclude the scheduled performance, being understood that above provisions will be in force.

## Requirements for pharmaceutical companies

In the case AIFA does not authorize application, the organizing committee will refund the amount paid in advance. SiVà will not accept as a valid motive for cancellation the missed or negligent presentation of the application to AIFA and therefore the above cited general clauses will be in force.

The organizational committee will handle the pre-application to AIFA for the authorization to the congress participation. The applications, included code SIS, must reach to SiVà not later than February 16th, 2015. SiVà snc disclaims all responsibilities for eventual inconveniences due to malpractice and/or compliance with deadlines.
